Program Basics



The U.S. government's "EB-5" Immigrant Investor Program provides foreign nationals with an opportunity to obtain U.S. permanent residency for themselves and their immediate family members in return for investing in an American business that creates new American jobs. In return, the investor, his or her spouse, and any unmarried children under the age of 21 become eligible to receive permanent U.S. residency, allowing them to live and work anywhere in the United States.

Background

Administered by the United States Citizenship and Immigration Services (USCIS), the EB-5 program approves and designates Regional Centers to attract foreign investment into the U.S. The EB-5 program has experienced explosive growth starting from a base of \$300 million of EB-5 capital in 2009 to over \$7 billion in 2015, primarily due to its long established guidelines and high individual approval rates.

Update

The U.S. Congress voted in early December 2016 to extend the EB-5 Regional Center program through April 28th, 2017. In January 2017, the USCIS proposed significant changes to the program including raising the minimum investment amount from \$500,000 to \$1,350,000. While this proposed change will not come into effect until after April 2017 at the earliest, it does represent a significant incentive for new investors to make the investment at the lower level before then.




EB-5 Market Dominated by China

- Foreign university students and graduates are subject to a highly competitive lottery system in order to obtain the required H1-B employer-sponsored visa []
- In April 2016, the USCIS held lottery for 65K H1-B visas from over 236,000 applications []
- H1-B visa holders from India, for example, typically wait 8 to 10 years for a green card []
- According to NY Times, nearly 70% of H1-B visas were issued to the top 5 Indian outsourcing firms in 2014





The Six EB-5 Requirements

Capital Investment

- \$500,000 into a new business or real estate project
- Over 98% of EB-5 investors invest through Regional Centers (government designation for EB-5 projects) at \$500,000 level

New U.S. Job Creation

• Create or preserve at least ten fulltime jobs for American workers

Background Check

 Proof that investor is not a convicted criminal, no history of financial fraud or has not previously violated U.S. immigration laws

Legally Sourced Investment

• Can clearly document that the funds required to make the investment come from a lawful source like salary, gifts of money, sale of assets, or loans


"At Risk" Investment

- Investment must be fully invested in the project for a period of no less than 5 years
- The EB-5 investor cannot be offered any guaranteed return on or of principal nor possess any redemption rights on capital


