He also designed and implemented change management, leadership and continuous improvement programmes for group subsidiary companies worldwide and led teams which won two Queen's Awards for Export Achievement.

After spells in the USA, Middle East and Japan Nigel joined Sheffield Chamber of Commerce in 1997 as Chief Executive Officer (at the age of 37 he was the youngest Chamber CEO in the UK) overseeing a dramatic change in the organization and its fortunes which coincided with the economic regeneration of Sheffield. As a result of these successes, Nigel was selected to serve as a director of the British Chambers of Commerce in 2008.
